



TUITION CONTRACT 2017-2018

The tuition for the 2017-2018 school year will be \$11,250.00 plus an activities fee of \$350.00. Levey Day School requires parents/guardians to enter into an agreement to pay tuition for the full year. Payment may be made in one of two ways:

1. **Payment in full by July 1, 2017, by check or credit card.**
2. **Payment monthly.** Payment may be made in ten monthly installments, by check or credit card commencing on July 1, 2017.
 - a. Ten checks, each made out for one-tenth of the tuition, must be provided to the school by July 1, dated the first of each month July 2017 through April 2018.
 - b. Alternatively, families may authorize the school to charge a credit card account monthly, for one-tenth of the agreed upon tuition from July through April. There will be a 3% fee added to help defray the cost of credit card fees.

Any deposit paid will be applied to the tuition.

The activities fee is due by July 1. No discounts may be applied and the fee is nonrefundable.

Any prior outstanding balances must be paid in full in order to re-enroll students for the upcoming school year.

Returned checks will incur a fee of \$20 per occurrence.

Withdrawal policy

If a student withdraws from the school before the end of the 2017-2018 school year, the following schedule of obligations will apply:

1. If the student withdraws between April 1 and July 31, 2017, the family is obligated to pay 20% of the tuition owed for the year.
2. If the student withdraws between August 1 and October 30, the family is obligated to pay 50% of the tuition owed for the year.
3. If the student withdraws between November 1 and January 31, 2018, the family is obligated to pay 75% of the tuition owed for the year.
4. If a student withdraws after January 31, the family is obligated to pay the entire year's tuition.
